

## Privacy Policy

Our data collection policies allow Users to choose how much information is provided, and to control the transmission of that information by selecting "No" to notification questions. ### Personal Information

### Cookies

Cookies, a standard industry technology, are small pieces of information or files that are stored on a user's computer by the Web server through a user's browser for record keeping purposes. The information can be retrieved to personalize, monitor, or regulate use of the site.
